#### 1. Sign-in / A Call to order

Chairman Petrea called the meeting to order at 6:33 p.m.

#### 2. Roll Call of Members Present

Chairman Petrea requested a roll call of Board members. The Chairman noted a quorum was present.

## 3. Public Hearing, Peanut & Food Allergy Policy

Opportunity for Public Comment

Pursuant to ORC §3313.719 and Ohio Department of Education Requirements, the Board held a Public Hearing for public comment on the Peanut & Food Allergy Policy. This policy requires staff to be trained and emergency protocols be put in place. There was no public comment.

#### 4. Reports and Updates

#### a. Head of School Report

Mr. Hessey gave the School/Operator Report. Professional Development was held virtually. They are getting classrooms ready.

Mr. Yoder was introduced to the Board, and he gave his educational background.

Outreach was discussed. Thursday, August 11<sup>th</sup> is Open House. The goal is to encourage more interaction between the staff and families. Member Bartlett inquired whether Board Members can watch Open House. Mr. Yoder said he would share with Mr. Hessey to share with the Board.

## Personnel Report

There are currently 27 staff members. Three (3) of four (4) math positions are currently open. Applications for those positions have been open and there have not been any applicants. The School may begin looking into tutoring companies. The School also has two (2) Intervention Specialist positions open. Marty

## b. Management Company Report

Mr. Arkin gave the Management Company Report. Gateway has passed Opening Assurances and will have their first day of school on August 15<sup>th</sup>.

Enrollment was discussed. There are 62 students actively enrolled. There are 88 more applications started and 66 applications are in progress. The School is on track to meet their enrollment goal of 500 students by early October. Marty Yoder, the School's principal, was introduced to the Board and said he was working with the staff to bring everything together for the start of the year.
